The Hon'ble Prime Minister of India, Shri Narendra Modi's vision to spread India's traditional Knowledge of Yoga at global level with credible systems has been well accepted globally, resulting in UN declaring 21st June as the International Day of Yoga in the year 2015, with the support of around 177 countries.

The Ministry of AYUSH (Ayurveda, Yoga & Naturopathy, Unani, Siddha and Homeopathy), Government of India, in pursuance of the above identified the Quality Council of India (QCI) which developed **Voluntary Yoga Certification & Accreditation Scheme** for Yoga Professionals.

TQ Cert Services Private Limited is the first Certification Body audited by Quality Council of India prior to its approval as a Personal Certification Body.

The Yoga Board under the Ministry of AYUSH has the following schemes for yoga professionals evaluation presently with two levels of competence:
